

Last week the department answered 89 calls since our last meeting on 13 March 2025.

Squad 2 was involved in a motor vehicle accident on 17 March 2025 with no injuries and has been transferred to a body shop for repair. In meantime Asst Chief Rogers is driving the new support vehicle we have had, and his vehicle is being used in place of Squad 2, Chairman Barrett was notified.

The new Dispatcher William Barelay has completed training and is assigned to Shift 2 working on his own.

Asst Chief Rogers met with public safety officials in plans for the Makepeace Triathlon that is coming in June.


